 - ii. 5,000\$ this semester

 - i. Highest attendance ever
 - ii. Cheapest for any FA gala.
 - d. Free coffee wednesdays
 - e. Advocacy
 - i. Boards, committees,

Presentation by the VP Finance

1. Dramatic change in budget due to FAMF
 - a. 4x budget increase due to FAMF
 - i. Massive expansion of all OASIS activities, and new activities
 - b. Income of 38,000\$
 - i. In flux due to lockers
 - ii. 30,000\$ from the FAMF. 2.50 from arts students each semester.
 - c. Biggest expense is granting
 - i. We pledged that 50% of our FAMF money would go to granting.
 - d. Projection for next year

- i. Projections are almost identical, but at the discretion of the next VP finance
 - e. Grants tripled
 - f. Arts gala takes up a large portion due to it being our largest events
- 2. Would you increase granting transparency?
 - a. Sure thats a good idea
 - i. We're still learning about granting since its the first year we've done this much.
 - b. We will provide more clarity.
- 3. Arts con
 - a. End of march
 - b. Event for arts students to present research and work
 - c. Will be in SUB
 - d. Can watch presentations, view artwork
 - e. If you're interested in presenting, we are accepting applications

 - a. Called by Chris Beasley
 - b. Unanimous approval.

- 3. Amendment 1
 - a. Changing the name of the granting committee to the finance committee
 - i. This is due to granting committee also being involved in budgeting
 - b. Passed Unanimously
- 4. Amendment 2
 - a. Channing all grammatical errors
 - i. Passed unanimously
- 5. Amendment 3
 - a. Changing section 4.09 to include the president on the finance committee without a vote
 - b. Called to a vote
 - i. Motion passed unanimously
 - ii. One abstention
- 6. Amendment 4
 - a. Changing section 4.09. Making the council positions on the granting committee elected by council
 - b. Motion passed unanimously
- 7. Amendment 5
 - a. Add a section to make sure all executives become a part of COFA and add the attendance to COFA as executive responsibility
 - b. Motion passed unanimously

8. Amendment 6
 - a. Section 4.10 and 5.09. Add the executive members to be a voting member of Council, however, they would be unable to vote on impeachment process.
 - b. Passed Unanimously
9. Amendment 7
 - a. Change section 5.01. Add an international student counselor position.
 - i. This has been added to ISSS. This would be in line with this and would increase international student involvement. Increase representation and expand council
 - b. Passed unanimously
10. Amendment 8
 - a. Changes the balance of councillors
 - i. 4 social sciences, 3 humanities, 2 fine arts, 1 interdisciplinary studies
 - ii. 14 in favour
 - iii. 1 opposed
11. Amendment 9
 - a. Quorum for impeachment. Amendment would make 2/3rds of council the only impeachment quorum requirement
 - b. Passed Unanimously
12. Amendment 10
 - a. Change the articles of impeachment to create a 50% threshold rather than 2/3rds
 - b. Passed Unanimously
13. Amendment 11
 - a. Removing section 8.02 sub A,B,C, and D.
 - i. New section A would allow the annual budget would be announced rather than presented. The budget would be approved by the executive rather than through the AGM.
 - b. 11 in favour
 - c. 1 abstention
14. Amendment 12
 - a. Amending section 8.08.
 - i. Allows reimbursements to be given through E-Transfer
 - b. Passed Unanimously
15. Amendment 13
 - a. Add section 8.01
 - i. Oasis will until not determined feasible by council will give free printing to oasis members
 - ii. Passed Unanimously
16. Amendment 14
 - a. Remove a portion of section 9.10
 - i. Would no longer be sent to the DIE board.
 - ii. This is at the behest of the DIE board.
 - iii. We would arbitrate internally or through an external commission.
